A VERY HAPPY RETURN

It's been said that timing is everything. For Carmen Chang, her return home to Wilson Sonsini Goodrich & Rosati was indeed a matter of timing—perfect timing.

The firm, after a careful analysis of the Asian market, decided in July that it was prepared to make Carmen the offer she'd wanted: an office in Shanghai and the opportunity to build the firm's China practice. Her temporary hiatus—a two-year stint with Wall Street firm Shearman & Sterling—had been motivated mainly by her need for a China platform to support her increasing transactions abroad.

"I grew up at Wilson," Carmen noted. "I only left because I wanted to do more in China. Now that the firm has committed to expanding its business and offering broader services in China, it's very exciting."

Today, having taken up the reins of the China practice, Carmen is spearheading expansion in the Asian region, working closely with Don Williams, who is overseeing the Shanghai office opening, and Lucas Chang, who, as the firm's chief representative in China, already has made significant inroads in the country. As a corporate securities expert, Carmen has broad experience in representing public and private technology companies and financial institutions in public offerings, mergers and acquisitions, joint ventures, financings, and many other types of transactions in the United States and abroad. This technology background combined with a unique knowledge of the Chinese business environment make her the perfect person to lead the firm's official foray into China.

"Carmen is a proven commodity," said Chief Executive Officer John Roos. "She has that unique combination of assets. Not only is she an outstanding corporate attorney, but she possesses a knowledge of the Chinese market and culture along with the business development and people skills to make everything come together seamlessly."

In leaving Shearman & Sterling, Carmen not only brought her entire team with her to Wilson Sonsini Goodrich & Rosati, but she was able to bring on board her enviable roster of clients, including Semiconductor Manufacturing International Corporation of Shanghai, UTStarcom, Spreadtrum Communications, and Alchip Technologies Limited.

"With my team intact, everything has been going very well. It's been an extremely smooth transition and, for ninety-nine percent of my clients, nothing has really changed," she pointed out. "Our current focus is on ramping up. We're spending considerable time on recruiting and training."





In addition to her China practice responsibilities, Carmen now holds a seat on the firm's Policy Committee—and thus a voice in the firm's direction. She hopes this position will help her to push the firm and her team further in the competitive Chinese market.

"In China, a relationship-based business plan is essential," explained Carmen. "I think it's important to note that in cultivating client relationships, it's different for a woman than a man in this business. I certainly never suffered

because of my gender, but I do think I had to work a bit harder *initially* to prove myself a competent and capable attorney. Establishing expertise is certainly a key to success with clients—in the United States and abroad.

"Along those same lines," she added, "I feel that being a woman also has been a benefit to me in my career. Many women seem to have an innate sensitivity that enables them to make people comfortable, to put them at ease. That's certainly important in building good relations,

especially in a culture like China's, which prizes cordial personal relationships as part of business dealings."

The firm applied in November 2005 for a license to open an office in China and hopes to open its doors in Shanghai by the summer of 2006. That won't be too soon for Carmen, who said, "Having an office to call our own will give tremendous credibility to our China practice and truly signals the firm's commitment to the region."

TAKING ATTORNEY RECRUITING TO THE NEXT LEVEL: NEW, MORE COMPREHENSIVE FOCUS LOOKS BEYOND HIRING—TO ATTORNEY CAREERS



Wilson Sonsini Goodrich & Rosati has long understood that attorney recruiting and retention are inextricably linked—and vital to its continued

success. Recently, the firm has taken steps to expand its efforts in these areas, and new initiatives—including career development and counseling, diversity, improved communications, and a focus on work/life integration—are intended to take the firm's recruitment and retention efforts to the next level.

As part of this strategy, in September 2005 the firm announced plans to merge the Attorney Recruiting department with its internal attorney-retention efforts. Carol Timm (pictured above) was

promoted to director of recruiting and retention, a new role at the firm. Previously, Carol was a senior corporate associate and had been very active in attorney recruiting.

In her new role, Carol manages the Attorney Recruiting group and the Career Services Center. She also serves as a liaison among internal groups that focus on recruiting and retention, such as the Hiring Committee, the Associates Committee, and the training/professional development department. Her job is to keep all groups thinking long-term. "What I bring to the table is a focus on tomorrow's attorney," Carol explained. "It's my job to make sure our initiatives will be on target today as well as in the years to come."

Law school students are particularly focused on the firm's career development

efforts: they zero in on programs related to professional development, mentoring, and flexible work policies. These programs have been expanding at Wilson Sonsini Goodrich & Rosati: already, Carol's group has introduced a new formal mentoring program for first-year associates as well as focused career guidance for sixth-year associates.

Carol also oversees the firm's diversity programs, including the women's initiatives. "My work with the women of the firm began as a grassroots effort with a group of talented female associates who were hoping to make a career with the firm," she said. "That group has been strengthened by the efforts of the Women's Initiative Network, which is led by our women partners and executives. This two-pronged effort, focusing on the support and advancement of women, has worked tremendously well for us."

progress on both. For starters, the path to partnership is becoming less mysterious because we do a better job at reaching out to mid-level associates about the process. Back in November [when new partners were announced], we invited each of the new women members to talk about their career paths, the choices they made, and how they navigated work/life integration. I predict that women associates will keep this type of dialogue going. The other topic on the radar is flexible work options. The part-time policy is often a topic of conversation, and we continually look for ways to promote that policy and help associates and partners in implementing it.
